## Acquisition of CLAAS leads ...

### ... to strong earnings increases

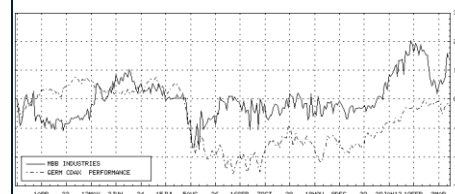
- The primary task of a holding company is to invest in attractive companies at reasonable prices. By the acquisition of CLAAS Fertigungstechnik GmbH, MBB took a significant step forward:
- CLAAS Fertigungstechnik is a leading international firm for plant engineering and construction specialising in welding and assembly systems for the automotive industry. We assume that approximately 80% of revenues come from this sector. It also offers innovative transportation technologies for exact positioning and inline measurement facilities. Other industries include aviation, solar and wind power, white goods and toolmaking.
- In FY 2011, the company generated sales of about EUR 100m. Due to its high exposure to the car industry and a strong order backlog, we assume further growth in the next years. We estimate EBIT margin to be in the middle, single-digit area.
- PwC estimates an average growth in worldwide car production until FY 2016 of 6.2%; CLAAS should benefit from this development.
- CLAAS' core competence lies in the field of "Joining Technology" and "Assembly line engineering". According to MBB, nearly all German car manufacturers are clients of CLAAS.
- Consolidation of CLAAS follows after closing of the deal in 2Q 2012. According to the management, MBB paid only nearly CLAAS' equity, meaning that no goodwill must be booked. Therefore the acquisition price must have been at a level of an attractive single-digit P/E.
- We clearly increase estimates. For the current business year we assume additional EUR 70m of sales with an EBIT of plus EUR 3.5m. For FY 2013, effects will be even higher due to a 12 months consolidation.
- Based on a DCF and peer group valuation, we increase our price target to EUR 12.00 (old: EUR 9.30). We clearly confirm our BUY recommendation.
